Grace Sherburne (MJ) presented an overview of the community engagement update:

Public Open House #2

- September 25, 5:30 7:30 PM at Village Hall, 60 Main Street
- Approximately 25 attendees
- Interactive station for the public to learn about proposed projects being evaluated by the LPC and to share their thoughts on transformational impact

Grace (MJ) noted the public open house was publicized through a flyer and social media graphic shared with the LPC. Grace (MJ) noted the MJ team passed out flyers downtown following LPC Meeting #4. An email blast was also sent to those who had signed up to receive updates and materials were shared on the Project Website.

Attendees were asked to place stickers in either High, Medium, or Low columns to indicate how transformative they think each project could be to Downtown Canton. The results for each project were averaged, shown below:

- Upgrade Riverside Drive Streetscape and Gouverneur Street Gateway Signage: High
- Enhance Park Amenities in the Village Green: Low
- Renovate 11 and 11 ½ Riverside Drive into a Commercial Fitness Center and Two Dance Studios: High
- Redevelopment of the Former Midtown Plaza: High
- Nature's Storehouse Expansion: High
- The Tick Tock Revival: High
- Renovations & Upgrades to the TAUNY Center: High
- Establish a Small Project Fund: High

5. Refined Project List Discussion

Discussion

Jaclyn Hakes (MJ) discussed the refined project list with the LPC and the criteria used to evaluate the proposed projects:

- Does the project sponsor have the capacity to implement the project?
- How do the project scopes compare in terms of downtown impact?
- Would the project be the best use of NY Forward funding?
- Does a project's location make it more or less competitive?
- Does a project's budget clearly identify costs and estimates?
- Is the project ready to proceed?
- Does the project align with the downtown Vision and Goals?

Grace Sherburne (MJ) provided project updates since LPC Meeting #4:

- A01 Upgrade Riverside Drive Streetscape and Gouverneur Street Gateway Signage
 - Updated budget
- A02 Enhance Park Amenities in the Village Green
 - Updated budget
- B01 Renovate 11 and 11 ½ Riverside Drive into a Commercial Fitness Center and Two Dance Studios
 - Removal of hazardous material (asbestos, mold, lead paint) is included within the 'Construction' line item in the budget
- B03 Redevelopment of the Former Midtown Plaza
 - Reduced NY Forward funding request to \$2,000,000

Grace (MJ) noted that all materials and correspondence have been shared with the LPC and uploaded to their respective folders. The MJ Team noted that all project sponsors have been very responsive during the NY Forward process.

Jaclyn Hakes (MJ) shared the preliminary projects list following LPC #4:

- 9 Projects Ready to Advance
- 6 Projects Not for NY Forward
- \$7.9 Million in NY Forward Requested Funds
- \$34.8 Million in Total Project Costs
- Costs do not include Projects Not for NY Forward

The LPC voted on a final slate of projects to be recommended for inclusion in the Strategic Investment Plan. This slate of project should represent a NYF Request of between \$6 - \$8 Million. The projects included on the Final Slate are:

- A01 Upgrade Riverside Drive Streetscape and Gouverneur Street Gateway Signage
- A02 Enhance Park Amenities in the Village Green
- B01 Renovate 11 and 11 ½ Riverside Drive into a Commercial Fitness Center and Two Dance Studios
- B03 Redevelopment of the Former Midtown Plaza
- B04 Nature's Storehouse Expansion
- B07 The Tick Tock Revival
- B08 Renovations & Upgrades to The TAUNY Center
- C01 Establish a Small Project Fund
- D01 Canton Branding and Marketing Initiative

7. Pipeline Project Discussion

Discussion

Jaclyn Hakes (MJ) discussed pipeline/supporting projects with the LPC:

 Pipeline/supporting are projects proposed in the NYF process that are great ideas but are not ready to receive NYF funding for a variety of reasons. For these projects, the LPC may elect to include these projects in the SIP as supporting pipeline projects. While not recommended for NYF funding, these projects are consistent with the goals of NYF and the community's vision

- and the LPC would like to include them as potential areas for revitalization within the downtown.
- Identifying projects as pipeline/supporting projects in the Strategic Investment Plan may also provide additional points when applying for other grant opportunities.

The LPC held a discussion on the potential pipeline projects:

- A03 Enhancements to Willow Island
 - o Identifying this project as a pipeline project would help in securing grant funding for resiliency/stabilization.
- B02 Renovate 95 Main Street to Become Accessible, Historic, and Energy Efficient
 - The LPC was in support of making this building more accessible
 - o Other funding sources available such as the Main Street grant
- B05 Renovate 51 Main Street to Make More Desirable for Customers and Provide Affordable Housing
 - o Project may qualify for Main Street grant
- B06 Upgrade the Frozen Spoon
 - Project aligns with the goal of providing dining options and shows support for the Small Project Fund
- B09 Mix-Use Redevelopment of 15 Gouverneur Street
 - LPC agreed this was an important project to be identified as a pipeline project
- B10 Third Floor Renovation of 75 Main Street into 3 Apartments
 - o The housing element of this project is important to the downtown

The LPC voted to include the following projects as Pipeline Projects in the Strategic Investment Plan:

- A03 Enhancements to Willow Island
- B02 Renovate 95 Main Street to Become Accessible, Historic, and Energy Efficient
- B05 Renovate 51 Main Street to Make More Desirable for Customers and Provide Affordable Housing
- B06 Upgrade the Frozen Spoon
- B09 Mix-Use Redevelopment of 15 Gouverneur Street
- B10 Third Floor Renovation of 75 Main Street into 3 Apartments

The LPC discussed the implementation process of the Small Project Fund should it be awarded by the State. The Small Project Fund is managed by Homes and Community Renewal and will be administered by the Village or a consultant hired by the Village. Should the Small Project Fund be awarded, an administrative plan will be defined, and a project review committee will be formed. Project applications will be reviewed and selected based on the timeline and eligibility included in the administrative plan.

The LPC discussed how the State decides which projects are funded from the final slate that's included in the Strategic Investment Plan. When reviewing the final slate of projects, the State will use the State Goals for NY Forward as well as the local Vision and Goals to evaluate project proposals.
